Notes to the short form expenditure summary for the 2024/25 financial year.

Expense category explanations

Aggregate remuneration expenditure	Summary of remuneration paid to our Executive Leadership Team and fees paid to our Board Directors. Fees may be paid directly to Directors, to a nominated company, or to the shareholder. For detailed remuneration information, please refer to the Fund Financial Report at bussq.com.au/disclosure.
Aggregate promotion, marketing or sponsorship expenditure	Summarises design, production and distribution of the Fund's promotional and educational materials, advertising and media, events, and sponsorships expenditure. This expenditure is necessary to grow the Fund and increase scale. This helps keep fees as low as possible.
Aggregate political donations	BUSSQ does not make political donations.
Aggregate industrial bodies	Summary of payments made to organisations registered under the Fair Work (Registered Organisations) Act 2009 which include union and employer organisations. Payments may also include Directors' fees, and promotion, marketing, and sponsorship expenditure. Fair Work Australia's list of registered organisations can be found at fwc.gov.au/registered-organisations/find-registered-organisation.
Aggregate related party payments	Summary of the payments made to BUSSQ subsidiary entities or for services from an organisation BUSSQ invests in. It also details services provided, and payments for services to, organisations that BUSSQ shares a Director or Executive with. Payments include promotion, marketing or sponsorship, Directors' fees, arrears collection, and other member services.
